all parents to become strong families. Strong families are able to:


- Manage stress when faced with challenges

Help parents find child care that best meets their family needs; documents parents' requests for child care services; maintains comprehensive databases of child care providers in their communities, including licensed family child care homes and child care centers; track providers' licensing status, the languages they speak, the age groups they serve, the schedules they offer, and the number of spaces available in centers or family child care homes; works with providers to improve the quality of child care and to maintain and expand the supply of child care in each county; provides training and other services that help providers stay in business; compiles and disseminates information on the statewide supply and demand for child care; and educates local communities and leaders to understand child care issues and to plan effectively to address child care needs. *Area Served: Stanislaus County*

Offered in child care centers and in family child care homes.

Pregnant women and children must have parents/guardians whose annual income comes primarily from migrant (moved in the last two years) or seasonal agricultural work. Offered in child care centers and in family child care homes. Area Served: Merced and Stanislaus County

### School Readiness Is Our Goal

Head Start programs are child-focused programs that have the overall goal of increasing school readiness and social competence of young children. The School Readiness Plan focuses on preparing infants, toddlers, as well as preschool aged children to be prepared to take on the expectations and tasks of the K though 12 educational system. Head Start programs implement the Creative Curriculum, which is a research-based curriculum that is aligned to California Infant/Toddler and Preschool Learning Foundations and Frameworks and the Head Start Early Learning Outcomes Framework. All are aligned to the California State Standards and Common Core Standards for kindergarten. Head Start programs developed and adopted school readiness goals (SRGs) in five central domains as mandated by the Improving Head Start for School Readiness Act of 2007 and found within the Head Start Early Learning Outcomes Framework.

The developmental progress of children on the school readiness goals is monitored using the California Desired Results Developmental Profile (DRDP2015) assessment tool for children. Caregivers and teachers use the DRDP to collect data regarding children's progress on specific measures of development and is fully aligned with state and federal standards. Child assessment data is collected three times per year, or twice for programs operating fewer than 90 days. DRDP data is analyzed and used in planning efforts to support individual children and group school readiness progress. Based on analysis of children's DRDP data, SRGs are identified for individual and groups of children and plans are developed in an effort to improve children's school readiness outcomes. Plans include support services such as professional development, family and community engagement, and program adjustments. SRGs and strategies are updated based on midpoint and endpoint DRDP data to guide improvement efforts.

Head Start programs use a wide range of screenings and evaluation tools to help assess children's progress, classroom environment and teacher effectiveness in effort to further support school readiness. The following include (but not limited to):

- The KSEP- Kindergarten Student Entrance Profile
- The CLASS- Classroom Assessment System
- Desired Results Developmental Profile (2015)-Infant/Toddler & Preschool
- Ages and Stages Questionnaires
- Ages and Stages Questionnaires- Social/Emotional
- Early Screening Inventory-Revised

The School Readiness Goals are developed by the School Readiness Advisory Committee which is comprised of Grantee, Delegate and Partner staff, as well as parents. Based on school readiness data analysis, program goal objectives are developed to target growth in all areas of the 5 central domains within the Head Start Early Learning Outcomes framework. The School Readiness Plan also includes identified teaching and family practices as well as identified professional development activities that support school readiness:





#### DOMAIN: SOCIAL AND EMOTIONAL DEVELOPMENT

### As part of Stanislaus County Office of Education's Destination

Graduation Initiative and the Stanislaus Reads! campaign, Child & Family Services assesses the kindergarten readiness skills of all four year old Head Start children just before they leave the program and enroll in kindergarten in the Fall. The research based tool that is used is the Kindergarten Student Entrance Profile (KSEP).

KSEP is an observation based tool that assesses a child's school readiness using the following 13 measures that scores skill level within a range of "not yet, emerging, almost mastered, mastered".

### Social-Emotional Items

- Seeks adult help when appropriate
- 2. Engages in cooperative play activities with peers
- 3. Exhibits impulse control and self-regulation
- 4. Maintains attention to tasks (attention focus, distractibility)
- 5. Is enthusiastic and curious about school
- 6. Persists with tasks after experience difficulty (task persistence, coping with challenges)

### School-Ready Knowledge Items

- 7. Recognizes own written name
- 8. Demonstrates expressive verbal abilities
- 9. Understands that numbers represent quantity
- 10. Writes own name
- 11. Recognizes colors
- 12. Recognizes shapes
- 13. Names UPPER CASE alphabet letters

In the 2015-2016 school year, 88% of Head Start children in Stanislaus County going on to kindergarten had an average score of Almost Mastered and higher.

ready for school and for a lifetime of academic success and, Head Start programs are valuable partners with families in this endeavor. Teachers and families develop a collaborative partnership to share about the child's development and goals. Parent and family engagement activities are grounded in positive, ongoing, goal oriented relationships with families. Parents attend monthly educational meetings where they learn about early childhood development and ways to enhance their



child's cognitive, physical, social and emotional skills. By participating in the program parents are building connections with other families and gaining knowledge of resources in their community. At each Head Start center a parent committee meets to provide input in activities planned for the center and take a leadership role in planning and hosting parent education events and meetings. Parents are serving as decision makers through shared governance of Head Start programs. Parents receive training in fiscal, program design, and service delivery, human resources, and employment decisions, as well as health and safety and child supervision. In the process they increase their understanding of early childhood and education business management and inform the program regarding the well-being of their children and families.



## DEVELOPING PROFESSIONALS

A highly trained and educated staff is the cornerstone of Child & Family Services. To continue to develop staff skills, no matter the position, Child & Family Services funds a robust and variety of professional development opportunities. Annually, over 500 professional development trainings, workshops, conferences, networking and learning opportunities are offered to early education professionals, including family child care home providers, in Stanislaus County and across the six other California Counties programs are operated in. One fourth of those offerings are available for the general public to attend. ### **Oversight and Monitoring**

As required by funding agencies, federally funded Head Start programs receive a rigorous monitoring review by the Office of Head Start annually during its 5 year grant period. Programs funded by the State of California receive a program evaluation every three years.

The Early Head Start, Head Start, Migrant and Seasonal Head Start, and Migrant Early Head Start programs received announced on-site monitoring reviews in the 2015-2016 program year. The areas reviewed included Environmental Health & Safety, Fiscal, Eligibility, Recruitment, Selection, Enrollment, and Attendance. One area of non-compliance related to Environmental Health and Safety in the Head Start and Migrant and Seasonal Head Start programs was found and corrected.

State funded programs also received an announced on-site full program evaluation in the 2015-2016 program year. Three areas of non-compliance related to Eligibility, Attendance, and Environment Rating Scale were found and corrected.

Child & Family Services had no out-of-compliance findings in the last completed financial audit.
